At the current time, the UENPS represents 28 countries, approximately six million neonates a year and over 600 million European citizens.

The UENPS offers itself as the most reliable interlocutor to tackle and discuss all issues surrounding perinatology, pregnancy, delivery and postnatal growth with Institutions and stakeholders.

Since its foundation, it has always been very conscious of the need for a more refined awareness of the various local and regional contexts in order to establish common standards of conduct and shared guidelines. At the same time, historical examples of divisions in Europe in the research sector have led to halts or significant delays in creating and implementing attractive economic resource networks. Furthermore, communication difficulties are, in some cases, largely owing to member states only partially identifying themselves as part of the UENPS.
